

KINDERGARTEN HEALTH Reference Sheet

1. IMMUNIZATIONS

- a. **Immunizations are a state law! Children must have all immunizations mandated by Utah Law completed prior to the first day of school.**
- b. **Pink Card Information:**
 - * All immunizations must have a day, month and year noted with official signature or clinic name.
 - * Any immunization record brought in by the parent must be an official document or it is **not** acceptable

REQUIREMENTS FOR KINDERGARTEN:

2 Chicken Pox, 2 Hepatitis A, 3 Hepatitis B, 2 MMR, 5 DPT, 4 POLIO

Refer to immunization requirements flyer in packet

If child has had chicken pox the parent must sign the pink form indicating this.

- c. **CONDITIONAL / NON -COMPLIANCE**
 - * A child can enter school if they are on schedule for all immunizations. They are considered conditional.
 - * If any child on conditional status is 30 days past due for any required immunization they are out of compliance and they will be excluded from school until they receive the immunizations or claim an exemption.
 - * Children **will not be admitted to school** if they are past due for any immunization!!!
- d. **EXEMPTIONS**

Medical (form obtained from Doctor), Religious, Personal (forms obtained only from local health department)

**ALL THE ABOVE NEEDS TO BE COMPLETED PRIOR TO THE FIRST DAY OF
KINDERGARTEN OR THE STUDENT WILL BE EXCLUDED FROM SCHOOL PER LAW**

It is the parent's responsibility to keep current with all their children's immunizations. You have 2 choices. Get the immunization or get the exemption. Don't make the school hound you!!!
Any student who is currently eligible (immunization due now or past due) for any school required immunization will be excluded from attending school until the immunization is received or exemption claimed and proper paperwork brought to the school.

2. HEALTH CONCERN

- a. If child has a health concern that needs attention at school, parent must let the school know directly. The school will then contact the nurse. Parent must fill out "Request Form for services" which can be found on the district website
- b. If Health Plan is needed, parent must contact school each year it is to be put in place.

3. MEDICATION FORMS

- a. No medications or treatments (prescription or over the counter) can be given at school until an official medication form has been signed by the doctor and the parent at the beginning of each year the medication is needed. (Utah Law)
- b. All medication must be in the original container (prescription and over the counter) Child can not carry any medication at school except for asthma inhalers if the prescribing doctor indicates on the med form that the student may carry and self administer the medication.
- c. All medication must be brought in by an adult and then counted with office staff

4. VISION

Before entering Kindergarten, all kids are required by state law to have a vision screening test. Have it done at their doctor's office and make sure doctor gives you something for the school stating that it was done.
